CERTIFICATE OF INCORPORATION

- of -

VISHWA HINDU PARISHAD OF AMERICA

Under Section 402 of the Not-for-Profit Corporation Law.

The undersigned for the purpose of forming a corporation under Section 402 of the Not-for-Profit Corporation Law, hereby certify:

1. Name. The name of the Corporation is VISHWA HINDU PARISHAD OF AMERICA.

2. Exempt status. The Corporation is constituted so as to attract substantial support from contributions, directly or indirectly, from a representative number of persons in the community in which it operates and has not been formed for pecuniary profit or financial gain, and no part of the assets, income, or profit of the Corporation is distributable to, or inures to the benefit of, its directors or officers except to the extent permitted under the Not-for-Profit Corporation Law. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this certificate, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Code) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States inter-

Internal Revenue Law).

3. Purposes. The purposes for which the corporation is to be formed are for scientific, educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 and, in this connection, to give primacy to the human and spiritual rather than to the material, values of life; to encourage the daily living by the Golden Rule in all human relationships; to create and promote a better understanding and more friendly relationship between races, nations and people; to cultivate, promote, foster, sponsor, and to develop the appreciation, understanding and love of Hindu songs, literature and heritage; to unite Hindus with a view to instill in them devotion to the principles and practices of Hindu ways of life; to cultivate a spirit of self-respect for Hindus and their ways of life and respect for the people of all colors, creeds, races and religions; to establish facilities for Hindu literature; to promote the celebration of Hindu festivals and to conduct and encourage gatherings, camps and conferences as may be deemed essential for the fulfillment of the ideals of good life; to establish friends in the United States by collecting funds, medicines, instruments and equipment for medical research, for the purposes of helping the poor and needy people; to do any other act or thing incidental to or connected with the foregoing purposes or advancement thereof, but not for pecuniary profit or financial gain of its directors or officers, except as permitted under the Internal Revenue Corporation Law.

✓ 4. Classification. The Corporation is a Type B corporation.

✓ 5. Principal Office. The City and County in which the Corporation's office is to be located is Brooklyn, New York, Kings County.

6. Place of Operation. The territory in which the Corporation's activities are principally to be conducted, is New York City, New York.

7. Limitation on Activities: Nothing herein shall authorize the Corporation, directly or indirectly, to engage in or include among its purposes, any of the activities mentioned in Not-for-Profit Corporation Law, Section 404(b)-(c) or Executive Law, Section 747.

8. Approvals and consents. Prior to the delivery to the Department of State for filing, all approvals or consents required by law will be endorsed upon or annexed to this certificate.

shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States internal revenue law), as the directors shall determine. Any of such assets not so disposed of shall be disposed of by the Supreme Court of the State of New York, County of Kings, exclusively for such purposes or to such organization or organizations as such court shall determine, which are organized and operated exclusively for such purposes.
