The areas of business shall include, but not be limited to, education, business administration, bookkeeping, staffing, and business operation services. In addition, the company's power and authority shall include, but not be limited to, wholesale and retail sales of products and/or services, the purchase, leasing, managing, and sale of real estate, strategic business planning, and business consulting of any kind.
