ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Congregation Chevras Shelim of Rhode Island

2. The period of its duration is (if perpetual, so state) perpetual

3. The specific purpose or purposes for which the corporation is organized are:

- To serve as a place of worship and an organizing agency of prayer groups for members of the Jewish faith, focusing on, but not limited to the Book of Psalms. To carry on the legacy of the Shelim (Psalms) society established by the Logins in 2002.
- To provide moral, spiritual and physical charitable support for members of the Jewish Community of Rhode Island, including, but not limited to: visiting the sick/infirm/aged; helping to organize clothing distributions to needy families.
- To provide any other services and perform any other functions, permitted by law, that a Church, Temple, or Synagogue may provide and/or perform.

4. Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

This organization is to be run according to Orthodox Jewish law and custom. Any internal dispute that cannot be resolved internally shall be resolved by means of arbitration of an Orthodox Rabbinic Counsel that is approved by Agudath B'Israel of America.
