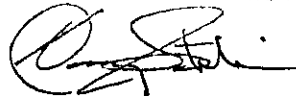
2. That the Recommendation on Allowance of Claims filed herein by said Receiver is hereby approved.

4. That the Receiver's administrative claim in the amount of \$33,669.40 is hereby allowed and the Receiver is authorized and directed to pay himself on account of said allowed administrative claim from the funds in the Receivership account in the amount of \$ 23,617.40.

5. That said Receiver is hereby authorized to abandon all Respondent's books and records and any outstanding assets.

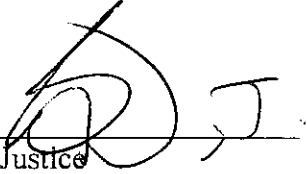
6. That said Receiver is hereby discharged and the Receivership Bond ordered cancelled.

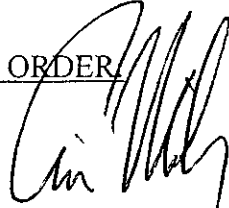
8. That this proceeding is now closed and may be reopened only upon the filing of a Motion.

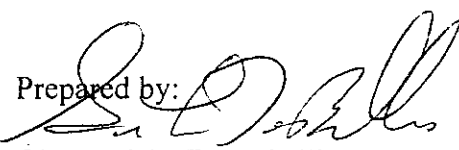

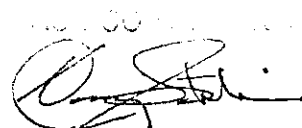

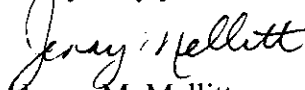
