ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Charlestown School PTO INC.

3. The specific purpose or purposes for which the corporation is organized are:
The corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Its purpose is to provide a means of ongoing and organized communication between parents and the school. None - In pursuance of the above purposes it shall carry on any business or other activity which may be lawfully conducted by a non-profit corporation organized under the State of Rhode Island, and do all things necessary, proper, and consistent with maintaining tax-exempt status under section 501(c)(3).
