Amended Certificate of Formation for George Limited Liability Company

This amended Certificate of Formation amending a limited liability company under the laws of the State of Rhode Island are made and executed this <u>10th day of October</u>, <u>2014</u>, by the undersigned.

- 1. **Name**. The name of the limited liability company is George, LLC (hereinafter referred to as the "Company").
- 2. **Term**. The term or period of duration of the Company shall commence as of the date of the filing of these Articles of Organization with the Rhode Island Division of Corporations and Commercial Code and shall continue for a term of twenty (20) years from that date, unless sooner terminated pursuant to law or the provisions of the Company's Operating Agreement.
- 3. **Business Purpose**. The character and purposes of the Company and its business are (1) real estate development & management; (2) to engage in any lawful act or activity for which companies may be organized under the laws of the State of Rhode Island; (3) to do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers herein set forth, either alone or in association with others, and incidental or pertaining to, or growing out of, or connected with, its business or powers, provided the same is consistent with the laws of the State of Rhode Island.

5. **Substitute Service of Process**. The Division of Corporations and Commercial Code of the Rhode Island Department of Commerce is hereby appointed as the agent of the Company for service of process if the registered agent has resigned, the registered agent's authority has been revoked, or the registered agent cannot be found or served with the exercise of reasonable diligence.

6. **Management**. The management of the company shall be vested in the Managers and a majority of the Managers voting shall be necessary for all decisions affecting the Company.
