ORDERED, ADJUDGED and DECREED as follows:

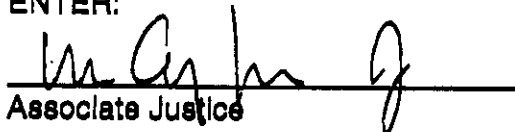

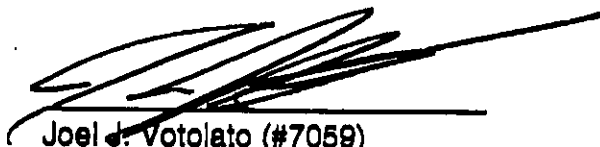
