

ADDENDUM TO ARTICLES OF ORGANIZATION OF
The Lares Group II, LLC

6. Additional provisions which the members elect to have set forth in these Articles of Organization:

6.1. The Members and Managers shall be indemnified by the Company to the fullest extent permitted by Rhode Island law. Without limiting the generality of the foregoing, the Company shall indemnify and hold harmless each Member and Manager, past or present, of the Company acting on behalf of the Company from and against any and all claims and liabilities including attorneys fees to which such person shall become subject by reason of his, her, or its having heretofore or hereafter been a Member or Manager of the Company or by reason of any action alleged to have been heretofore or hereafter taken or admitted by him or her in such capacity and shall reimburse each such Person for all legal and other expenses, including reasonable attorneys' and paralegal fees, reasonably incurred by him, her, or it in connection with any such claim or liability.

Notwithstanding the foregoing, no such Member or Manager shall be indemnified against or reimbursed for any expense incurred in connection with any claim or claims made against him, her, or it that the Company has reasonably determined to have resulted from: (a) any breach of said Person's duties of loyalty to the Company or its Members; (b) acts or omissions not in good faith or which involve willful misconduct, gross negligence, or knowing violation of law; or (c) a transaction or transactions from which the Person seeking indemnification derived improper personal benefit.
