Non-Profit Corporation Articles of Incorporation

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is The Helping Veterans Association

ARTICLE II

The period of its duration is X Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

Our mission is to assist the homeless Veterans in our area of operation through any means at our disposal. We will be networking with various federal, state, local and private organizations to have as effective a reach as possible. We will be providing goods, products, education and connection to services for our clients. Most services will be provided by effectively utilizing our network of agencies and organizations. We will also give direct aid through donation of tangible goods to those in need as we are able to do so. These goods will be procured through direct purchase, by funds gained through fundraisers and donations, and donations received from those desiring to support our mission. Our ultimate goal is to aid our clients to achieving self-sustainability.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

ALL DECISIONS WILL REQUIRE A VOTE OF THE BOARD OF DIRECTORS. ALL VOTES MUST BE UNANIMOUS.

THERE WILL BE THREE MANAGING POSITIONS THAT RUN THE COMPANY. THESE POSITIONS WILL BE

FILLED BY AN ANNUAL VOTE OF THE BOARD OF DIRECTORS. THE THREE POSITIONS AND THE PEOPLE

<u>FILLING THEM ARE AS FOLLOWS: CHIEF OPERATIONS OFFICER – ALICIA HOLMES,</u> CHIEF FINANCIAL

<u>OFFICER – WILLIAM E. ROWELL, AND CHIEF ADMINISTRATIVE OFFICER – BENJAMIN HIGHT.</u>
