ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is GOD'S GRACE INTERNATIONAL CHURCH, INC. (IGLESIA INTERNACIONAL LA GRACIA de Dios)

2. The period of its duration is (if perpetual, so state) PERPETUAL

3. The specific purpose or purposes for which the corporation is organized are:
This corporation is organized for the purpose of conducting a church, ministry, and any legal activity conducted by non-profit corporations under the laws of the State of Rhode Island under section 501 (C) (3) of the Internal Revenue Code of the United States of America. More specifically, but without reservation or restriction, this corporation shall be organized and operated exclusively for religious, educational, and charitable purposes within the meaning of section 501 (C) (3) of the Internal revenue Code of 1954, as amended, or any superseding section. This Corporation shall, among other things, organize Youth Development Programs, Feeding Programs, Community Outreach, and other activities as deemed fit.

4. Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:
Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the nonprofit purposes of the corporation and the corporation shall not carry on any activity not permitted to be carried on by an organization exempt from any Federal income tax under section 501 (C) (3) of the Internal Revenue Code, or under the corresponding section of any future United States Revenue law.
