Articles of Incorporation

(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Ocean State Kombucha Corp

This is a close corporation pursuant to § 7-1.2-1701 of the General Laws, 1956, as amended. (Uncheck if inapplicable.)

ARTICLE II

The total number of shares which the corporation has authority to issue is:

A statement of all or any of the designations and the powers, preferences, and rights, including voting rights, and the qualifications, limitations, or restrictions of them, which are permitted by the provisions of Chapter 7-1.2 of the General Laws, 1956, as amended, in respect of any class or classes of shares of the corporation and the fixing of which by the articles of association is desired, and an express grant of the authority as it may then be desired to grant to the board of directors to fix by vote or votes any of them that may be desired but which is not fixed by the articles:

(A) ACTION BY THE SHAREHOLDERS PURSUANT TO RHODE ISLAND GENERAL LAWS, 1956, AS AMENDED, (RIGL) §7-1.2-707(B) IS HEREBY AUTHORIZED.

(B) NO DIRECTOR OR SHAREHOLDER UNDERTAKING TO EXERCISE THE RESPONSIBILITIES OF A DIRECTOR SHALL HAVE PERSONAL LIABILITY TO THE CORPORATION OR TO ITS SHAREHOLDERS FOR MONETARY DAMAGES FOR BREACH OF SUCH DIRECTOR'S OR SHAREHOLDER'S DUTY AS A DIRECTOR OR, IN THE CASE OF A SHAREHOLDER, DUTY AS A PERSON UNDERTAKING TO EXERCISE THE RESPONSIBILITIES OF A DIRECTOR; PROVIDED THAT THIS PROVISION SHALL NOT ELIMINATE OR LIMIT THE LIABILITY OF SUCH DIRECTOR OR SHAREHOLDER FOR: (I) ANY BREACH OF SUCH DIRECTOR'S OR SHAREHOLDER'S DUTY OF LOYALTY TO THE CORPORATION OR ITS SHAREHOLDERS; (II) ACTS OR OMISSIONS NOT IN GOOD FAITH OR WHICH INVOLVE INTENTIONAL MISCONDUCT OR A KNOWING VIOLATION OF LAW; (III) LIABILITY IMPOSED PURSUANT TO THE PROVISIONS OF RIGL §7-1.2-811; OR (IV) ANY TRANSACTION FROM WHICH SUCH DIRECTOR OR SHAREHOLDER DERIVED AN IMPROPER PERSONAL BENEFIT (UNLESS SAID TRANSACTION IS PERMITTED BY RIGL §7-1.2-807).

(C) PURSUANT TO RIGL §7-1.2-1701 (D), ANNUAL MEETINGS OF SHAREHOLDERS SHALL NOT BE REQUIRED UNLESS ONE OR MORE SHAREHOLDERS DELIVER WRITTEN NOTICE TO THE CORPORATION REQUESTING A MEETING AT LEAST THIRTY (30) DAYS BEFORE THE MEETING DATE STATED OR FIXED IN ACCORDANCE WITH THE BYLAWS OF THE CORPORATION.
