**ARTICLE I**

The name of the corporation is Womens Trouble

The specific purpose or purposes for which the corporation is organized are:

To provide an ever growing community of homeless women with menstrual cups and access to clean safe facilities. often times shelters do not provide women with tampons or pads which can force women to use unhealthy alternatives which often lead to infection. menstrual cups are worn longer and are reusable for up to a year. the government provide free condoms to women but do nothing to help an issue that affects so many women. Womens Trouble will provide these women with menstrual care and personal hygiene issues. We will be a safe haven for so many women who are on the streets to escape domestic violence.
