RESTATED ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 7-1.2-906 of the General Laws of Rhode Island, 1956, as amended, the undersigned corporation adopts the following Restated Articles of Incorporation:

1. The name of the corporation is Mearthane Products Corporation
2. The shareholders of the corporation (or, where no shares have been issued, the board of directors of the corporation) on February 19, 2016, in the manner prescribed by Chapter 7-1.2-903 of the General Laws, 1956, as amended, adopted the following amendment(s) to the Articles of Incorporation:

Article Fourth of the Articles of Incorporation is hereby amended as follows:

Article Fourth is deleted in its entirety and replaced with the following:

5. These Restated Articles of Incorporation shall be effective upon filing unless a specified date is provided which shall be no later than the 90th day after the date of this filing Upon filing
