ORIGINAL ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is BELLEVUE-CHRE POINT NEIGHBORHOOD ASSOCIATION
2. The period of its duration is (if perpetual, so state) Perpetual May 1, 2038
3. The specific purpose or purposes for which the corporation is organized are:
To preserve and protect the BELLEVUE-CHRE POINT neighborhood against any threat,
imminent or reasonable anticipated, to the quality and enjoyment of its
residential character.
4. Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation:
The Founders, those who organized the group and initially raised the funds to accomplish
the mission and other Members-at-large who have at least contributed \$100 annually to
preserve the neighborhood and the organization's mission shall have one vote. A
quorum will be a majority of Founders. A majority vote of all members present is
required to pass a resolution. Two weeks prior notice to all members prior to
meeting required.


