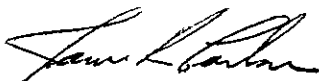
Because you do not hold a certificate of authorization to practice architecture within the State of Rhode Island, please be advised that in the event that this Board should determine that you have practiced or offered to practice architecture within this State, to include providing proposals for architectural work, the Board will view this as a willful and intentional violation of Rhode Island law and will take action accordingly. Such actions by this Board may include the referral to the Attorney General's Office for criminal prosecution in accordance with Title 5, Chapter 1, of the Rhode Island General Laws.

This will be the last written communication you will receive on this subject matter from this Board. The expense of continuously sending out documents can no longer be borne by the Board. In the event that you wish to pursue your application for a certificate of authorization, you must complete the application process as directed **within thirty (30) days of the date of this letter**. **If the Certificate of Good Standing is not received within this final 30-day period, the Board will not take any further action on your application, and on that deadline date, you must cease and desist from practicing or offering to practice architecture in the State of Rhode Island.** Failure to do so will result in the denial and termination of the application process by this Board.

If you have any questions regarding obtaining your Letter of Good Standing please feel free to contact the Secretary of State's office at 401-222-3040 and ask for Corporations. **Please keep in mind that unless we receive the Certificate of Good Standing to complete your application for COA from you within thirty (30) days of the date of this letter, your application will be terminated without further notice to you.**

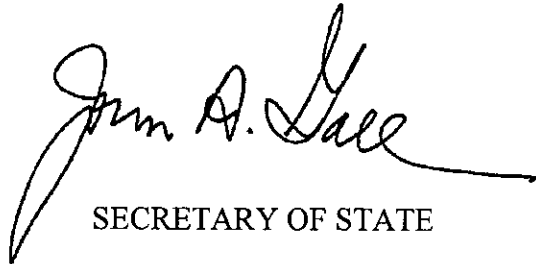

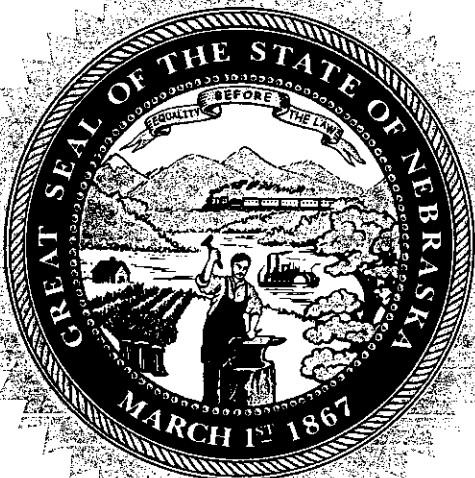

ARTICLES OF INCORPORATION

OF

WILSCAM & MULLINS, INC.

The undersigned natural person of the age of twenty-one years or more, acting as an incorporator of a Corporation under the Nebraska Business Corporation Act, hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of this Corporation shall be WILSCAM & MULLINS, INC.

ARTICLE II

The period of the Corporation's duration is perpetual.

ARTICLE III

The purposes for which this Corporation is organized are the following:

(a) To prepare architectural plans and specifications; to enter into and perform contracts for architectural work; to supervise erection of, to build for its own account or for others, structures of every character, and to render, in connection therewith or independently thereof, such additional services as the Corporation may deem proper, including, but not limited to, landscaping, planting, grading, road building and earth work of every character; to practice the profession of architecture in all its fields and branches; and to do and perform any and all things connected with or related to the profession and practice of architecture.

(b) To engage in and perform engineering, and engineering services of every kind and nature; to enter into and perform contracts for engineering,

and engineering services of all kinds; to practice the profession of engineering in all of its fields and branches; to act as consulting engineers and practice surveying; and to do and perform any and all things connected with or related to the profession and practice of engineering.

(c) To operate and conduct a general construction and contracting business, including the designing, constructing, enlarging, repairing, remodeling or otherwise engaging in any work of any type whatsoever upon buildings, highways, roads, sidewalks, curbing, guttering or bridges; to engage in wood, brick, concrete, stone, cement, masonry, iron, steel, earth and other constructions; and to execute contracts or to receive assignments of contracts therefor, or relating thereto; and to manufacture and furnish the building materials and supplies connected therewith.

(d) To manufacture, use, distribute and sell goods, wares, merchandise, implements, machines and products of every kind and description.

(e) To do everything necessary, proper, advisable or convenient for the accomplishment of the purposes hereinabove set forth, and to do all other things incidental thereto or connected therewith which are not forbidden by the laws of the State of Nebraska, or by these Articles of Incorporation.

ARTICLE IV
