TO VACATE THE FORFEITURE OR REVOCATION OF THE CHARTER OF THE RHODE
ISLAND COMMODORES

Introduced By: Representative K. Joseph Shekarchi

Date Introduced: May 20, 2015

Referred To: House Corporations

It is enacted by the General Assembly as follows:

1 SECTION 1. The time within which the Rhode Island Commodores, incorporated
2 December 23, 1975, shall file the reports for the years 2002, 2003, 2004, 2005, 2006, 2007, 2008,
3 2009, 2010, 2011, 2012, 2013, 2014, and 2015 as required under the provisions of § 7-6-90 of the
4 general laws of Rhode Island, 1956, is hereby extended to the 31st day of December, A.D., 2015,
5 if said corporation shall file in the office of secretary of state before December 31, 2015, the
6 reports which it should have filed in the said years and shall pay to the secretary of state the filing
7 fees therefor, having previously thereto paid to the general treasurer for the use of the state such
8 sum as the attorney general shall decide should be paid by said corporation as a compromise for
9 the penalty or penalties for its failure to file such reports then the forfeiture or revocation of the
10 charter of said corporation shall thereupon, to wit, upon the filing of said reports and the payment
11 of said fees, be vacated and said corporation shall thereupon be entitled to all of the privileges,
12 benefits and powers and subject to the same duties and liabilities as though no forfeiture or
13 revocation of its said charter had taken place.

14 SECTION 2. This act shall take effect upon passage.
