**Non-Profit Corporation
Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Skills for Life Corporation

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

Skills for Life Inc is a non-profit corporation and shall be operated exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Federal tax code.

We teach life skills, which we define as human skills which are used to handle problems and questions commonly encountered in daily life. Workshops in auto-repair, home repair, plumbing, clothing, cooking, self-defense, and art. At any point, workshops may cover any new skills for which the organization sees evidence of their utility. Workshops will be made available to all participants who are interested in learning regardless of any person's ability to pay for such instruction.

Our programs include monthly open-enrollment workshops which address a specific skill, a life-skills day camp for kids henceforth known as Camp Sparkle, and community outreach in the form of public information on the importance of learning life skills.

At times, per the discretion of the board of directors, we may provide internships or volunteer opportunities which shall provide opportunities for involvement in said activities and programs in order to have a greater impact for change.
