He shall notify the Board of Directors of his desire to sell or transfer by notice in writing, which notice shall contain the price at which he is willing to sell or transfer. The directors shall within sixty days thereafter either accept or decline the offer by notice to him in writing.

After the acceptance of the offer or the Directors proposal of the value of the stock, the directors shall have ninety days within to purchase the stock. But, if at expiration of the ninety days the corporation shall not have exercised the right to purchase the owner of the stock shall be at liberty to dispose of the same in any manner he so fit.

No shares of stock shall be sold or transferred on the books of the corporation until these provision have been complied with, but the Board of Directors may in particular instance waive the requirements.
