Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is BLACKBERRY RADIO INCORPORATED

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

The preservation of Hiphop Culture through broadcast and social media and management of broadcast media and delivery of broadcast programs for historic, educational, recreational, or open on-air personality opportunities. To inform, educate and entertain through broadcast media and to assist unsigned and independent musicians and artists in securing prominent placement on radio and broadcasting playlists and in media.

NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON (1) BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE OR (2) BY A CORPORATION CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170(C)(2) OF SAID CODE, OR THE CORRESPONDING PROVISIONS OF ANY FUTURE STATUTE OF THE UNITED STATES.

IVA. C. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THIS CORPORATION SHALL CONSIST OF CARRYING ON PROPAGANDA OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION; NOR SHALL THE CORPORATION PARTICIPATE OR INTERVENE IN ANY POLITICAL CAMPAIGN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF

STATEMENTS)  
ON BEHALF OF ANY CANDIDATE FOR PUBLIC OFFICE.
