6. That your Receiver shall hold \$2,000 of the remaining funds in the Receivership Estate

for the final wind down and the Administration of the Estate. Should there be any

additional funds remaining after the complete wind down and destruction of all books

and records of the Receivership Estate, the Receiver shall release the balance of the

remaining funds to Northeast LP IV, LLC, without further application to this Court;
