Articles of Incorporation

Pursuant to the Rhode Island Nonprofit Corporation Act under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, the undersigned incorporator(s) hereby adopt(s) the following Articles of Incorporation for such corporation:

Article I

The name of this corporation is Momma and Babies Dog Rescue, Inc.

Article II

The period of duration of this corporation is perpetual.

Article III

The purposes for which this corporation is organized are:

- To serve as a non-profit organization dedicated to rescuing dogs from high euthanizing shelters by placing them into safe, loving, permanent homes through adoption;
- To conduct business as an all-volunteer, foster home based organization operating out of Rhode Island and Massachusetts;
- To provide rescue efforts placing specific emphasis on pregnant and nursing dogs who, along with their litters, would otherwise be euthanized;
- To ensure access to all veterinary services needed, including spay and neutering;
- To focus on helping overcrowded Southern shelters that are overpopulated due to high rates of abandonment, strays, abuse and neglect;
- To seek opportunities to support other rescues through sharing resources, education, and providing community support;
- To educate about and place many specific breeds of both cats and dogs that are notoriously difficult to place in permanent homes;
- To educate and reduce the high euthanization rates common to certain bully breeds and black cats; and
- To save as many animals in need as possible.

The organization is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code;

And,

Upon dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the IRC, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
