CERTIFICATE OF INCORPORATION

STATE

FIRST: The name of the corporation is "OXFORD HOUSE, INC."

SECOND: The address of the registered office of the corporation in the State of Delaware is 15 Ashley place P.O. BOX 3037, Wilmington DE 19804. The name of the registered agent of the corporation at such address is Michael F. Tucker.

THIRD: The purposes for which the corporation is being formed are as follows:

(a) To improve the rehabilitation, industrial, and social condition and environment for recovering alcoholics, by the development of plans and programs for their recovery and rehabilitation and by establishing, operating, and maintaining homes for recovering alcoholics.

(b) To work in cooperation with private and governmental agencies concerned with the problem of alcoholism.

(c) To do any act or thing incidental to or in connection with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors or officers.

(d) Said organization is organized exclusively for charitable, and educational purposes including for such purposes, the making of distributions or organizations that qualify as exempt organizations under Section 501 (c) (3) of the internal

Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

(e) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, except that the corporation shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of the purposes set forth in this paragraph. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contribution to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

(f) Upon the dissolution of this organization assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

FOURTH: The corporation is not authorized to issue capital stock.

FIFTH: The name and mailing address of the incorporator is Michael F. Tucker, 15 Ashley place P.O. BOX 3037 New Castle, County, Wilmington, Delaware, 19804.
