Restated Articles of Incorporation**

(Section 7-6-42 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is C.O.R.E. Development Institute, Inc.

IF VOLUNTARY DISSOLUTION PROCEEDINGS HAVE NOT BEEN REVOKED, THEN WHEN ALL DEBTS, LIABILITIES, AND OBLIGATIONS OF THE CORPORATION HAVE BEEN PAID AND DISCHARGED, OR ADEQUATE PROVISION HAS BEEN MADE FOR THEM, AND ALL OF THE REMAINING PROPERTY AND ASSETS OF THE CORPORATION HAVE BEEN TRANSFERRED, CONVEYED, OR DISTRIBUTED IN ACCORDANCE WITH THE PROVISIONS OF THIS CHAPTER AND FOR EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, ARTICLES OF VOLUNTARY DISSOLUTION SHALL BE EXECUTED BY THE CORPORATION BY ITS PRESIDENT AND OFFICERS OF THE CORPORATION, AND SHALL SET FORTH:

1. THE NAME OF THE CORPORATION.

2. BECAUSE THERE ARE NO MEMBERS IN THE CORPORATION, A STATEMENT OF THE FACT, THE DATE OF THE MEETING OF THE BOARD OF DIRECTORS AT WHICH THE RESOLUTION TO DISSOLVE WAS ADOPTED AND A STATEMENT OF THE FACT THAT THE RESOLUTION RECEIVED THE VOTE OF A MAJORITY OF THE DIRECTORS IN OFFICE, WHICH REQUIRES AT LEAST 70 PERCENT OF THE VOTING BOARD MEMBERS PRESENT.

3. THAT ALL DEBTS, OBLIGATIONS, AND LIABILITIES OF THE CORPORATION HAVE BEEN PAID AND DISCHARGED OR THAT ADEQUATE PROVISION HAS BEEN MADE FOR THEIR PAYMENT.

4. A COPY OF THE PLAN OF DISTRIBUTION AS ADOPTED BY THE CORPORATION, OR A STATEMENT THAT NO PLAN WAS ADOPTED.

5. THAT ALL THE REMAINING PROPERTY AND ASSETS OF THE CORPORATION HAVE BEEN TRANSFERRED, CONVEYED, OR DISTRIBUTED IN ACCORDANCE WITH AND AS DEFINED BY THE STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS.

6. THAT THERE ARE NO SUITS PENDING AGAINST THE CORPORATION IN ANY COURT, OR THAT ADEQUATE PROVISION HAS BEEN MADE FOR THE SATISFACTION OF ANY JUDGMENT, ORDER, OR DECREE WHICH MAY BE ENTERED AGAINST IT IN ANY PENDING SUIT.
