Articles of Incorporation**

(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Savor Master Corp.

This is a close corporation pursuant to § 7-1.2-1701 of the General Laws, 1956, as amended. (Uncheck if inapplicable.)

ARTICLE V

Additional provisions, if any, not inconsistent with Chapter 7-1.2 which the incorporators elect to have set forth in these Articles of Incorporation:

SHARES OF STOCK OF THE CORPORATION WILL BE TRANSFERABLE IN THE MANNER PRESCRIBED BY LAW AND IN THE CORPORATION'S BY-LAWS. TRANSFERS OF SHARES OF STOCK OF THE CORPORATION MAY ONLY BE MADE ON THE BOOKS OF THE CORPORATION, BY TRANSFER AGENTS DESIGNATED TO TRANSFER SHARES OF STOCK OF THE CORPORATION, OR BOTH. SUBJECT TO APPLICABLE LAW, SHARES OF STOCK REPRESENTED BY CERTIFICATES MAY ONLY BE TRANSFERRED ON THE BOOKS OF THE CORPORATION, BY THE SURRENDER TO EITHER THE CORPORATION OR ITS TRANSFER AGENT OF THE CERTIFICATES REPRESENTING SUCH SHARES, EITHER PROPERLY ENDORSED, OR ACCOMPANIED BY A WRITTEN ASSIGNMENT OR POWER OF ATTORNEY PROPERLY EXECUTED, AND WITH SUCH PROOF OF AUTHORITY OR THE AUTHENTICITY OF SIGNATURE AS EITHER THE CORPORATION OR ITS TRANSFER AGENT MAY REASONABLY REQUIRE. EXCEPT AS MAY BE OTHERWISE REQUIRED BY LAW, THESE ARTICLES OF INCORPORATION, OR THE CORPORATION'S BY-LAWS, THE CORPORATION MAY TREAT THE RECORD HOLDER OF STOCK, AS SHOWN ON THE BOOKS OF THE CORPORATION, AS THE OWNER OF SUCH STOCK FOR ALL PURPOSES, INCLUDING THE PAYMENT OF DIVIDENDS AND THE RIGHT TO VOTE WITH RESPECT TO SUCH STOCK, REGARDLESS OF ONE OR MORE TRANSFERS, PLEDGES, OR OTHER DISPOSITIONS OF SUCH STOCK, UNTIL SUCH SHARES HAVE BEEN TRANSFERRED ON THE BOOKS OF THE CORPORATION IN ACCORDANCE WITH THE REQUIREMENTS OF THE CORPORATION'S BY-LAWS.
