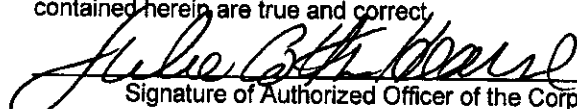
APPLICATION FOR CERTIFICATE OF WITHDRAWAL

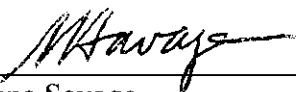

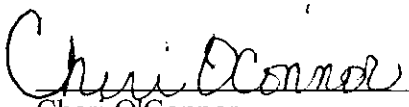
