ARTICLES OF ORGANIZATION

6. Additional provisions (if any) not inconsistent with law, which the members elect to have set forth in these Articles of Organization:

A member or manager of the Limited Liability Company shall not be personally liable to the Limited Liability Company or to its members for monetary damages for breach of any duty provided for in Section 17 of the Rhode Island Limited Liability Company Act, as may herein be amended (the "Act"), except for:

- 1. Liability for breach of a member, or a manager's duty of loyalty to the Limited Liability Company or its members;
- 2. Liability for acts or omissions not in good faith or which involve intentional misconduct or knowing the violation of law;
- 3. Liability imposed pursuant to the provisions of Section 32 of the "Act";
- 4. Liability for any transaction from which the member or manager derived an improper personal benefit, unless said transaction was with the informed consent of the members or a majority of the disinterested managers.
