CERTIFICATE OF INCORPORATION
OF

A NEW BEGINNING FOR IMMIGRANT'S RIGHTS, INC.

Under Section 402 of the Not-for-Profit Corporation Law

FIRST: The name of the corporation is: **A New Beginning for Immigrant's Rights, Inc.**

SECOND: The corporation is a corporation as defined in subparagraph (a) (5) of Section 102 (Definitions) of the Not-for-Profit Corporation Law. Nothing herein shall authorize this corporation directly or indirectly, to engage in or include among its purposes, any of the activities mentioned in the not-for-profit corporation law, section 404 (a)-(v).

THIRD: The purpose or purposes for which the corporation is formed are as follows:
Specifically, the organization will provide direct services and educational opportunities for immigrants.

Services will include non-attorney representation of indigent immigrants who are Victims of a crime as well as pro bono legal representation of immigrants before immigration Authorities upon approval of BIA Recognition.

Educational programs will focus on immigrant's issues such as but not limited to;

- Free ESL Classes,
- Basic Computer Class,
- Human Rights Training Seminal and Classes,
- Employment Rights Seminal and Classes,
- Environmental Protection Seminal and Classes,
- OSHA Safety Training Seminal,
- Free Beauty, Manicure and Pedicure Training for Domestic Violence Victim,
- Free Driving Classes for Victim of Domestic Violence,
- Coping with Domestic Violence Seminal,
- Domestic Violence Entrepreneurship Training and Seminar,
- USA Citizenship Class.

a) A New Beginnings for Immigrant's Rights, Inc. is organized for exclusively religious, charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under said Section 501(c)(3) of the Internal Revenue Code of 1986.

b) Notwithstanding any other provisions of these articles, the corporation is organized exclusively for one or more of the purposes as specified in 501(c)(3) of the Internal Revenue Code 1986 (the "IRC"), and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under IRC 501(c)(3) or corresponding provisions of any subsequent Federal tax laws.

c) No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporation assets on dissolution of the corporation.

d) No substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by IRC 501(h)), and the corporation shall not participate in, or intervene in (including the publication or distribution of statements), any political campaign on behalf of (or in opposition to) any candidate for public office.

e) In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another organization exempt under IRC 501(c)(3), or corresponding provisions of any subsequent Federal tax laws, or to the Federal government or state or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of New York.

In any taxable year in which the corporation is a private foundation as described in IRC 509(a), the corporation shall distribute its income for said period at such time and manner as not to subject it to tax under IRC 4942, and the corporation shall not (a) engage in any act of self-dealing as defined in IRC 4941(d), retain any excess business holdings as defined in IRS 4943(c), (b) make any investments in such manner as to subject the corporation to tax under IRC
