Articles of Incorporation

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is BCC ADONAI ELOHIM CHRISTIAN MINISTRIES INC

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

The specific purpose is to spread the gospel Jesus Christ Throughout the teaching and preaching of the word of God and to perform all activities inherent to a church.

To erect and maintain a building or buildings for the above purpose and to engage in any operation incidental to and essential to carry out the purposes above mentioned.

To receive and maintain real or personal property, rent, lease or purchase.

To solicit funds and donations in kind and from time to time to further the purposes of this corp.

To acquire and received by purchase, donation or otherwise, any real personal or mixed and to hold, used and dispose of the same.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

1. NO PART OF THE NET EARNINGS OF THE ORGANIZATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO ITS MEMBERS, TRUSTEES, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT ORGANIZATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF THE PURPOSE SET FORTH IN THE PURPOSE CLAUSE HEREOF.

2. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL CONSTITUTE THE CARRYING ON OF PROPAGANDA OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, OR ANY INITIATIVE OR REFERENDUM BEFORE THE PUBLIC, AND THE CORPORATION SHALL NOT PARTICIPATE IN, OR INTERVENE IN

(INCLUDING BY PUBLICATION OR DISTRIBUTION OF STATEMENTS), ANY POLITICAL CAMPAIGN ON BEHALF OF, OR IN OPPOSITION TO, ANY CANDIDATE FOR PUBLIC OFFICE.

3. NOTWITHSTANDING ANY OTHER PROVISIONS OF THIS DOCUMENT, THE ORGANIZATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OR CORRESPONDING SECTION OF ANY FUTURE TAX CODE, OR BY AN ORGANIZATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170(C)(2) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE TAX CODE.

4. NO PAYMENTS OR DISTRIBUTIONS SHALL BE MADE BY THIS CORPORATION AND NO OTHER ACTIVITIES SHALL BE CARRIED ON OR ENGAGED IN BY THIS CORPORATION FROM FEDERAL INCOME TAXATION UNDER THE PROVISIONS OF THE INTERNAL REVENUE CODE OF 1986, AS AN ORGANIZATION DESCRIBED IN SEC. 501(C)3 OF SAID CODE OR THE DEDUCTIBILITY OF CONTRIBUTIONS TO AND FOR THE USE ON THIS CORPORATION FOR FEDERAL INCOME TAX PURPOSES UNDER THE PROVISIONS OF SEC.170 OF SAID CODE, OR THE DEDUCTIBILITY OF ANY TRANSFER DEVICE OR BEQUEST TO SAID CORPORATION FOR FEDERAL STATE PURPOSES UNDER THE PROVISIONS OF SEC.2055 AND SEC.2105 OF SAID CODE, OR THE DEDUCTIBILITY OF GIFTS TO SAID CORPORATION FOR FEDERAL GIFT TAX PURPOSE UNDER THE PROVISIONS OF SEC.2522 OF SAID CODE.
