- Reinstatement of charter forfeited by Rhode Island Division of Taxation

Section V – Dissolution/Cancellation of Domestic Entities (All reasons)

- Articles of Dissolution
- Conversion to non-Rhode Island entity
- Cancellation with the Rhode Island Department of State

Section VI – Withdrawal Cancellation of Foreign Entities (All reasons)

- Withdrawal due to merger
- Withdrawal of corporation's right to due business in Rhode Island
- Cancellation of entity's right to due business in Rhode Island
