Article 6 Additional Provisions:

- A. The purpose of the Company shall be to engage in the distribution. sale, processing, blending and packaging of beverages, ice cream toppings and related products, to sell, distribute or lease containers and equipment applicable to the products, to buy, sell, own and lease real estate and any other activity permitted by law.
- B. The manager is authorized on behalf of the Company to take any other acts or execute any other documents on behalf of the Company.
- C. The manager is authorized on behalf of the Company to authorize any one or more of the managers or officers of the Company to take any of the actions described in the preceding subsections.
- D. No member or other person who is not a manager is authorized to act or execute documents on behalf of the Company.
- E. No member or manager shall be obligated for any debt, obligation or liability of the Company solely by reason of being a member or acting as a manager of the Company.
- F. If members owning a majority Membership Units in the Company do not approve of a member's proposed transfer of all or any portion of the Member's Units in the Company, the transferee (referred to as a "Transferee Nonmember") shall have no right to become a member.
- G. A Transferee Nonmember shall, nonetheless, be subject to the provisions applicable to Unit Owners generally contained in the Company's Operating Agreement in effect from time to time, including, without limitation, the provisions as to tax allocations and provisions restricting transfer of Units.
