Macari Baby, Inc. Attachment to Section 2 of the Articles of Incorporation

The Corporation shall be authorized to issue one thousand (1,000) shares of voting common stock without par value and one thousand (1,000) shares of non-voting common stock without par value.

The holders of the voting common stock shall have the right to vote on matters to come before the stockholders of the Corporation and the holders of the voting common stock shall have one (1) vote for each share of voting common stock registered on the books of the Corporation in such voting stockholder's name.

The holders of the non-voting common stock shall have no right to vote on matters to come before the stockholders of the Corporation but, except for the right to vote, shall be entitled to all other benefits that the holders of the voting common stock have.
