It is enacted by the General Assembly as follows:

1 SECTION 1. The time within which The Executives Association of Rhode Island, Inc., 2 incorporated on December 15, 1939, shall file the reports for the years 1992, 1993, 1994, 1995, 1996, 1997, 1998, 1999, 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2007, 2008, 2009, 2010, 3 2011, 2012, 2013, 2014, 2015 and 2016 as required under the provisions of §7-6-90 of the general 4 laws of Rhode Island, 1956, is hereby extended to the 31st day of December, A.D., 2016, if said 5 corporation shall file in the office of the secretary of state before December 31, 2016, the reports 6 7 which it should have filed in the said years and shall pay to the secretary of state the filing fees 8 therefor, having previously thereto paid to the general treasurer for the use of the state such sum 9 as the attorney general shall decide should be paid by said corporation as a compromise for the 10 penalty or penalties for its failure to file such reports then the forfeiture or revocation of the 11 charter of said corporation shall thereupon, to wit, upon the filing of said reports and the payment 12 of said fees, be vacated and said corporation shall thereupon be entitled to all of the privileges, 13 benefits and powers and subject to the same duties and liabilities as though no forfeiture or 14 revocation of its said charter had taken place.

SECTION 2. This act shall take effect upon passage.
