Line 4: Brief Description of the character of business conducted in Rhode Island:

To establish a fitting, regular and annual observance of the capture and burning of the British customs schooner, "Gaspee", by Rhode Island men off the shore of Namquid Point in Warwick on the night of June 9, 1772.
