EXHIBIT A

Any shareholder, including the heirs, assigns, executors or administrators of a deceased shareholder, desiring to sell or transfer such shares owned by him/them shall first offer it to the corporation by notifying the corporation of his/her desire to sell or transfer by notice in writing, which notice shall contain the price at which he/she is willing to sell or transfer. The corporation shall, within 30 days thereafter either accept or reject the offer, but if at the expiration of thirty days the corporation shall not have exercised the right to purchase, the owner of such shares shall be at liberty to dispose of the same at a price not less than that offered to the corporation.
