To Whom It May Concern:

In January of 2016, at the monthly meeting of Quota International of Woonsocket, the President of the Club, Ms. Connie Plotkin, indicated that a number of members expressed an interest to disband the Club. She did not bother to contact the Regional President or the District President to inquire about proper procedure.

She polled the membership and then decided to vote by secret ballot. No official ballot was printed. The vote was taken on blank paper with the members simply writing "YES" or "NO". Some members did not understand the instructions and thought a "Yes" vote indicated a wish to dissolve the Club while others understood that a "Yes" vote would indicate a desire to keep the Club. As a result, the members present voted and the President declared the Club dissolved. She immediately instructed the Treasurer to write a check to the R I Secretary of State to dissolve the Club. She also instructed the Secretary to mail in the necessary paperwork as soon as possible. The Secretary mailed in the paperwork the following morning.

A number of members approached me, as President elect, and asked if the Club could continue with the reduced membership. I contacted the R I Secretary of State's office three days after the meeting and was told it was too late to stop the dissolution paperwork that had already been received by her office.

I contacted the Quota International Regional Director and told her our situation. She in turn called the International office. I found out that the vote to dissolve the Quota International of Woonsocket club was taken illegally and without the knowledge of the Regional or International offices. I was also told that as long as Quota International of Woonsocket had a President, a Secretary and a Treasurer in place until April 2016, when official elections could be held, the Club could continue to function. These three offices were filled and we have continued to function with our lesser numbers.

I have been working with Representative Robert Phillips of Woonsocket, R.I. to have the Club reinstated to its former status with the State of R I.
