Articles of Incorporation**

(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Bayside Auto Repair, Inc

This is a close corporation pursuant to § 7-1.2-1701 of the General Laws, 1956, as amended. (Uncheck if inapplicable.)

TO DO ANY OR ALL OF THE THINGS SET FORTH TO THE SAME EXTENT AS NATURAL PERSONS MIGHT OR COULD DO IN ANY PART OF THE WORLD AS PRINCIPALS, AGENTS, OR OTHERWISE, AND EITHER ALONE OR WITH OTHERS, AND TO DO EVERY ACT AND THING NECESSARY, CONVENIENT OR PROPER FOR THE ACCOMPLISHMENT OF ANY OF THE POWERS HEREIN STATED, PROVIDED THE SAME BE NOT INCONSISTENT WITH THE LAWS OF THE STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS APPLICABLE TO A BUSINESS CORPORATION. THE FOREGOING CLAUSES SHALL BE CONSTITUTED BOTH AS OBJECTS AND POWERS, AND IT IS EXPRESSLY INTENDED THAT NO SPECIFIC ENUMERATION SHALL RESTRICT IN ANY WAY GENERAL LANGUAGE, THAT NONE OF THE PURPOSES SET FORTH IN ANY OF THE ABOVE CLAUSES SHALL BE LIMITED OR RESTRICTED IN ANY WAY BY THE TERMS OF ANY OTHER CLAUSE, THAT EACH PURPOSES MAY BE PURSUED INDEPENDENTLY OF ANY OTHER PURPOSE FROM TIME TO TIME AND WHEREVER DEEMED DESIRABLE, AND THAT THE CORPORATION SHALL HAVE AND POSSESS ALL THE RIGHTS AND PRIVILEGES AND POWERS NOW OR HEREAFTER CONFERRED BY THE LAWS OF THE STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS UPON BUSINESS CORPORATIONS ORGANIZED UNDER SUCH LAWS.
