Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is FF Realty Corporation

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

This corporation is organized exclusively for charitable activities (within the meaning of Section 501(c)(3) of the Internal Revenue Code) benefiting, performing the functions of, and carrying out the purpose of Farm Fresh Rhode Island, Inc., a Rhode Island Nonprofit Corporation, specifically, ownership and lease of a facility for Farm Fresh Rhode Island.

This corporation may carry on any other activity in support of and to benefit the above purposes as may be carried on by a corporation described in Section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future federal tax code) and organized under the Rhode Island Nonprofit Corporation Act.
