**BEFORE ME**, the undersigned, Notary Public in and for the State and Parish aforesaid, personally appeared the undersigned party of full age of majority whose signature is subscribed below and who declares, in the presence of the undersigned competent witnesses, that availing himself of the provisions of the Louisiana Nonprofit Corporation Law (Louisiana R.S. 12:201 et seq. (1950, as amended), he does hereby organize a nonprofit corporation under and in accordance with the following Articles of Incorporation as follows:

**ARTICLE 1**

The name of this Nonprofit Corporation shall be **NEW HARMONY ARTISTS' GUILD, INC.**, and, under this corporate name, it shall be authorized to engage in any lawful activity for which corporations may be formed under LSA-R.S. 12:201 et seq. and that it shall have, enjoy and possess all the powers, rights, privileges and immunities which corporations are, and may hereafter be authorized to have and possess under the constitution and the laws of the State of Louisiana and more particularly LSA-R.S. 12:201 to 12:269, inclusively, as amended.

**ARTICLE 2**

The location of its registered office is 5617 Pratt Drive, New Orleans, Louisiana 70122.

**ARTICLE 3**

The corporations's registered agent for service of process

shall be John Hammons, 5617 Pratt Drive, New Orleans, Louisiana 70122.

#### ARTICLE 4

This corporation shall be a non-profit corporation. It shall have no capital stock and shall operate on a non-stock basis. There shall be no shareholders. It shall be operated and maintained by such dues and contributions as the membership shall make and as the board of directors shall determine to be necessary or acceptable for the proper functioning of the corporation. The qualifications for and classes of membership shall be set forth in the bylaws, including the designations, voting powers, and other rights or privileges, restrictions or limitations, granted to or imposed upon the members of each class.

#### ARTICLE 5

No part of the net earnings or assets of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purposes set forth in these Articles. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any

other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding provision of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding provision of any future federal tax code.

#### ARTICLE 6

This corporation is organized and operated exclusively for charitable, literary, and educational purposes, no part of the net earnings of which inures to the benefit of any private shareholder of individual, no substantial part of the activities of which is carrying on propaganda, or otherwise attempting, to influence legislation and does not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office. Activities may also include making distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future federal tax code. It is intended that this corporation be exempt from federal income tax under Internal Revenue Code Section 501(a) as an organization described under Section 501(c)(3) of the Internal Revenue Code.

#### ARTICLE 7

The corporation will use a calendar year fiscal year.

#### ARTICLE 8

The management of this corporation shall be vested in a Board

of Directors which shall consist of no less than three members in good standing of the corporation to be elected by the membership of the corporation at the annual meeting of the corporation. The terms of the Board of Directors shall be set forth in the bylaws; however, members of the Board of Directors shall serve not less than a one year term nor more than a five year term but may serve successive terms. The Board of Directors shall elect a President, Vice-President, Secretary, and Treasurer from the Board's membership during each term to serve until the next board shall be duly elected as herein provided. The first Board of Directors of this corporation and its first officers shall be those persons stated herein and they shall serve until the expiration of their terms as set forth in the bylaws or at the first annual meeting to be held as set out herein.
