Articles of Incorporation**

(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is ROAD RUNNERS FOOD MART, INC.

This is a close corporation pursuant to § 7-1.2-1701 of the General Laws, 1956, as amended. (Uncheck if inapplicable.)

TO CARRY ON ANY BUSINESS PERMITTED BY THE RHODE ISLAND AND THE PROVIDENCE PLANTATION GENERAL LAWS.

The corporation has the purpose of engaging in any lawful business, and shall have perpetual existence until dissolved or terminated in accordance with Chapter 7-1.2.

**ARTICLE V**

Additional provisions, if any, not inconsistent with Chapter 7-1.2 which the incorporators elect to have set forth in these Articles of Incorporation:

ANY STOCKHOLDER, INCLUDING THE HEIRS, ASSIGNS, EXECUTORS OR ADMINISTRATORS OF THE STOCKHOLDER; DESIRING TO SELL OR TRANSFER SUCH STOCK OWNED BY HIM/HER OR THEM, SHALL FIRST OFFER IT TO THE CORPORATION THROUGH THE BOARD OF DIRECTORS. THE PRICE SHALL BE SET BY THE MARKET VALUE THROUGH TWO INDEPENDENT ARBITRATORS, IF THE CORPORATION DOES NOT EXERCISE THEIR RIGHT TO PURCHASE, THEN THE SELLER SHALL POST THE STOCKS TO AN OUTSIDE THIRD PARTY APPROVED BY THE BOARD.
