EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OR

SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT FOR A

PUBLIC PURPOSE. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THIS

CORPORATION SHALL CONSIST OF

<u>CARRYING ON PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE</u> LEGISLATION (EXCEPT AS

OTHERWISE PROVIDED BY SECTION 501(H) OF THE INTERNAL REVENUE CODE), AND THIS CORPORATION

SHALL NOT PARTICIPATE IN, OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF

STATEMENTS), AND POLITICAL CAMPAIGN ON BEHALF OF, OR IN OPPOSITION TO, ANY CANDIDATE FOR

PUBLIC OFFICE. NO PART OF THE NET EARNINGS OF THIS CORPORATION SHALL

INURE THE BENEFIT OF, OR

BE DISTRIBUTEABLE TO, ITS MEMBERS, DIRECTORS, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT

THIS CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY

REASONABLE COMPENSATION FOR

SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS

INFURTHERANCE IF THE PURPOSE
