**CERTIFICATE OF INCORPORATION for the formation of NAAIP BUSINESS INC.**

NAAIP BUSINESS INC. is, by Chakchiuma Tribal Trust Council decree, tribally chartered and established under the Chakchiuma Sectchi Tribal Trust and in accordance with the "CONSTRUCTIVE AND PUBLIC NOTICE" of the "Chakchiuma Sectchi Tribal Trust Charter", dated June 9<sup>th</sup>, 2015 in the State of Tennessee, Shelby County Register of Deeds Document Number 11056046.

The Chakchiuma Sectchi Tribal Trust must file the "CONSTRUCTIVE AND PUBLIC NOTICE" of the creation and establishment of NAAIP BUSINESS INC. within 30 days of this notice. The notice must include that "NAAIP BUSINESS INC." also known as "NAAIP BUSINESS INC.", is a tribal business tribally chartered and established under the Chakchiuma Sectchi Tribal Trust. This business is created and operated in accordance with the charter and public notice of the Chakchiuma Sectchi Tribal Trust, and is owned and operated exclusively by the Chakchiuma Sectchi Tribe.

This honorable, respectful and proper "CONSTRUCTIVE AND PUBLIC NOTICE" formally initiates the genuine efforts of the Chakchiuma Sectchi Tribe to engage and establish NAAIP BUSINESS INC.

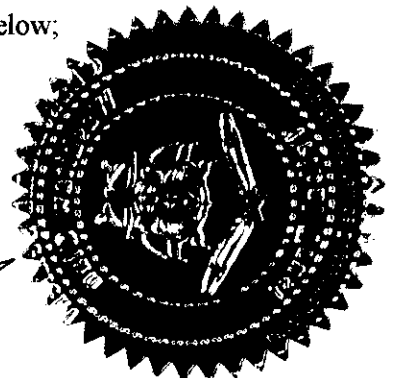
