Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is CITIZENS FOR BARRINGTON MIDDLE SCHOOL, INC.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE ADVANCEMENT OF EDUCATIONAL PROGRAMS FOR CHILDREN; TO ADVOCATE FOR VOTES IN SUPPORT OF THE BALLOT REFERENDUM TO FUND THE CONSTRUCTION BOND FOR A NEW PUBLIC MIDDLE SCHOOL IN BARRINGTON, RI; ACTIVITIES RELATED TO THE ENHANCEMENT AND FURTHERANCE OF EDUCATION OF CHILDREN; TO OPERATE AS A 501(C)(4) TAX-EXEMPT ORGANIZATION PROMOTING EDUCATION.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

UPON DISSOLUTION, ANY REMAINING ASSETS OF THE COMPANY SHALL BE DONATED TO A TAX-EXEMPT CHARITABLE ORGANIZATION.

AT ANY TIME, THE CHAIRPERSON OF THE BOARD OF DIRECTORS SHALL BE AUTHORIZED TO DISSOLVE AND WIND DOWN THE AFFAIRS OF THE COMPANY.

IN THE EVENT THE COMPANY DOES NOT OR CANNOT OBTAIN TAX-EXEMPT ORGANIZATIONAL STATUS FROM THE INTERNAL REVENUE SERVICE, THE COMPANY SHALL DISSOLVE AND WIND DOWN ITS AFFAIRS.

EACH DIRECTOR SHALL SERVE FOR A TERM OF TWO YEARS FROM THE COMMENCEMENT OF FILING OF THESE ARTICLES. UPON RESIGNATION OF A DIRECTOR, THE REMAINING DIRECTORS SHALL UNANIMOUSLY NOMINATE AND APPROVE OF A REPLACEMENT. AT NO TIME SHALL BE COMPANY HAVE LESS THAN TWO DIRECTORS.

IN THE EVENT THAT THE COMPANY FAILS TO HAVE THE REQUISITE NUMBER OF DIRECTORS FOR A PERIOD OF SIX MONTHS, THE COMPANY SHALL DISSOLVE AND WIND DOWN ITS AFFAIRS.

ALL DIRECTORS AND OFFICERS SHALL BE INDEMNIFIED, DEFENDED AND HELD HARMLESS FOR THEIR ACTIONS AND DECISIONS RELATED TO THE COMPANY TO THE FULLEST EXTENT AVAILABLE BY LAW. THE COMPANY RELEASES AND WAIVES ALL CLAIMS AGAINST THE DIRECTORS AND OFFICERS RELATED TO ACTS OR OMISSIONS RELATED TO THE COMPANY TO THE FULLEST EXTENT AVAILABLE BY LAW.

THE ACTING PRESIDENT OF THE COMPANY SHALL HAVE THE AUTHORITY TO BIND AND CONTRACT ON BEHALF OF THE COMPANY.
