Articles of Incorporation

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is NORTH EAST ANIMAL RESCUE

ARTICLE II

The period of its duration is  Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO RECEIVE AND CARE FOR ABUSED, NEGLECTED, STRAY OR UNWANTED DOGS, ESPECIALLY, BUT NOT EXCLUSIVELY, THOSE NEEDING RESCUE FROM SHELTERS THAT MAY BE FULL OR HIGH KILL. WE SHALL PROVIDE: A) VETERINARY CARE FOR RESCUED ANIMALS IN ORDER TO HELP ELIMINATE THE RISK OF DISEASE AND FURTHER OVER-POPULATION B) A SAFE HAVEN FOR ANIMALS TO LIVE, EITHER THROUGH FOSTER CARE OR A KENNEL ENVIRONMENT WHEN AFOREMENTIONED IS UNAVAILABLE, UNTIL FITTING ADOPTION BECOMES AVAILABLE C) COMMUNITY OUTREACH AND EDUCATION IN ORDER TO PREVENT ANIMAL ABUSE, NEGLECT AND GENERAL MISTREATMENT OF ANIMALS. AS WELL AS, EDUCATION ON THE IMPORTANCE OF SPAYING AND NEUTERING, VACCINATIONS AND APPROPRIATE ANIMAL CARE, AND ABOUT BREED PREJUDICE AND PROPER TRAINING.
