Articles of Incorporation

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is KUYATEH FAMILY FUND

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

UNITE ALL KUYATEH DECENDENTS OF THE LATE IBRAHIM (BLAMAH JARDRU) KUYATEH AND HIS LATE BROTHER ALIPHA KUYATEH IN THE UNITED STATES OF AMERICA, LIBERIA, GUINEA, CANADA AND OTHER COUNTRIES OF THE WORLD. THE FUND WILL HELP MEMBERS OF KUYATEH FAMILY IS CASE OF DEATH, EMERGENCY, INVESTMENT, VACATION AND CHARITABLE WORK AS DEFINED BY THE BYE LAWS OF THE ORGANIZATION. THE FUND WILL MAINTAIN, OWN, USE OR OTHERWISE POSSE, SELL, CONVEY, MORTGAGE, LEASE, OR OTHERWISE DISPOSE OF PROPERTY REAL AND CHATTEL; AS MAY BE NEEDED FOR THE BEST INTEREST OF THE ORGANIZATION AND ITS MEMBERS. CONDUCT ANY AND/OR ALL LAWFUL AFFAIRS FOR WHICH AN ORGANIZATION MAY BE INCORPORATED IN THE UNITED STATES OF AMERICA AND ELSE WHERE.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE MEMBERS OF THE BOARD OF DIRECTORS SHALL NOT BE THAN 3 OR MORE THAN 7. DIRECTORS SHALL BE ELECTED EVERY FIVE YEARS. THERE IS NO TERM LIMIT FOR THE DIRECTORS.
