





Dissolution and Liquidation annexed hereto as Exhibit A.

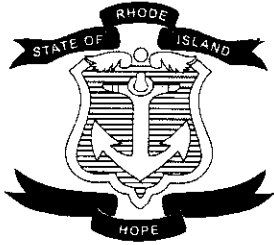
There being no further business to come before the meeting, it was upon motion duly made and seconded, unanimously
