(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is George W. Steere, Jr., CPA, Inc.

ARTICLE V

Additional provisions, if any, not inconsistent with Chapter 7-1.2 which the incorporators elect to have set forth in these Articles of Incorporation:

(A) ACTION BY THE STOCKHOLDERS PURSUANT TO RHODE ISLAND GENERAL LAWS, (1956), AS AMENDED (RIGL), § 7-1.2-707(B) IS HEREBY AUTHORIZED.

(B)NO DIRECTOR OR STOCKHOLDER UNDERTAKING TO EXERCISE THE RESPONSIBILITIES OF A DIRECTOR SHALL HAVE PERSONAL LIABILITY TO THE CORPORATION OR TO ITS STOCKHOLDERS FOR MONETARY DAMAGES FOR BREACH OF SUCH DIRECTOR'S OR STOCKHOLDER'S DUTY AS A DIRECTOR OR, IN THE CASE OF A STOCKHOLDER, DUTY AS A PERSON UNDERTAKING TO EXERCISE THE RESPONSIBILITIES OF A DIRECTOR; PROVIDED THAT THIS PROVISION SHALL NOT ELIMINATE OR LIMIT THE LIABILITY OF SUCH DIRECTOR OR STOCKHOLDER FOR: (I) ANY BREACH OF SUCH DIRECTOR'S OR STOCKHOLDER'S DUTY OF LOYALTY TO THE CORPORATION OR ITS STOCKHOLDERS; (II) ACTS OR OMISSIONS NOT IN GOOD FAITH OR WHICH INVOLVE INTENTIONAL MISCONDUCT OR A KNOWING VIOLATION OF LAW; (III) LIABILITY IMPOSED PURSUANT TO THE PROVISIONS OF RIGL § 7-1.2-811; OR (IV) ANY TRANSACTION FROM WHICH SUCH DIRECTOR OR STOCKHOLDER DERIVED AN IMPROPER PERSONAL BENEFIT {UNLESS SAID TRANSACTION IS PERMITTED BY RIGL § 7-1.2-807).

(C) THE CORPORATION NEED NOT HOLD AN ANNUAL MEETING OF SHAREHOLDERS UNLESS ONE OR MORE SHAREHOLDERS DELIVERS WRITTEN NOTICE TO THE CORPORATION REQUESTING A MEETING AT LEAST THIRTY (30) DAYS BEFORE THE MEETING DATE STATED OR FIXED IN ACCORDANCE WITH THE BYLAWS OF THE CORPORATION.
