ORIGINAL ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Teachers' Association of Newport, Newport Political Action Committee For Education (T.A.N. NEWPACE)

SECOND: The period of its duration (if perpetual, so state). Perpetual

THIRD: The purpose or purposes for which the corporation is organized are:

The purpose of T.A.N. NEWPACE is to encourage members to register to vote, to be responsible for the promotion and distribution of information about desirable candidates for Newport public offices, to endorse candidates for Newport elections, to make contributions for local elections, and to contribute money to members running for local office or the state Senate or House with the recommendation of NEWPACE.

FOURTH: Provisions (if any) for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation, are:

T.A.N. NEWPACE shall be a voluntary, non profit organization. The chairperson will make monthly reports, including endorsements and expenditures.

Provision for Distribution of Assets on Dissolution or Final Liquidation:
The Executive Board shall, after paying or making provisions for the payment of all liabilities of the organization, dispose of all of the assets to such organizations organized and operated exclusively for such purposes as the Executive Board shall determine.
