ORIGINAL ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Quonset Davisville Navy Yacht Club

SECOND: The period of its duration (if perpetual, so state) Perpetual

THIRD: The purpose or purposes for which the corporation is organized are:

- a. To encourage recreational boating and competitive sailing.
- b. To promote seamanship, piloting, navigation, and water safety.
- c. To provide berthing, storage, and repair facilities for members' yachts.
- d. To organize opportunities for members to take part in all forms of yachting and boating and to furnish members with advice and information.
- e. To sponsor activities in QDNYC such as sailing, power boating, fishing or such other activities as the members may desire.
- f. To encourage and promote liaison between members of this Club and other military and civilian recreational organizations.

FOURTH: Provisions (if any) for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation, are:

Club has provisions for collecting annual membership dues and fees for berthing facilities. All funds are under the control of an elected treasurer and subject to annual audit.

All Club officers are elected annually and are responsible for operation of the Club. Committee chairpersons are appointed annually to conduct specific Club functions.

There are no specific provisions for liquidation of assets should the Club dissolve.
