APPLICATION OF COMMISSIONERS OF THE TOWN OF PORTSMOUTH HOUSING AUTHORITY  
FOR A CORPORATE CHARTER PURSUANT TO SECTION 45-26-5, GENERAL  
LAWS OF RHODE ISLAND, 1956.

Now come the undersigned, who, being duly sworn make affidavit as follows:

(1) That on the 10th day of September, A.D. 1962, pursuant to section 45-26-2, General Laws of Rhode Island, 1956, the Honorable Council of the Town of Portsmouth did determine that there was a need for a Town Housing Authority to function in the Town of Portsmouth; the said Town Council on its own motion by resolution duly passed and approved by the Town Council of the Town of Portsmouth, on the same date, determined that (a) unsanitary or unsafe inhabited dwelling accommodations existed in the Town of Portsmouth, and (b) that there was a lack of safe or sanitary dwelling accommodations in the Town of Portsmouth available for the inhabitants thereof; and consequently that there was a need for a local housing authority to function in the Town of Portsmouth;

That pursuant to Section 45-26-5, General Laws of Rhode Island, 1956, the Honorable Town Council of the Town of Portsmouth duly appointed the undersigned Commissioners of the Town Housing Authority of the Town of Portsmouth, Rhode Island.

(2) That the following are the names and residences of the undersigned Commissioners appointed by the Town Council of the Town of Portsmouth.




