

majority, for the purpose of forming a non-profit corporation under and pursuant to the provisions of Chapter 24 South Dakota Session Laws 1965, known as the South Dakota Non-Profit Corporation Act, and law amendatory thereof and supplementary thereto, and for the purposes, expressed in Article III hereof, do hereby associate ourselves as a body corporate and adopt the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be MAPPING YOUR FUTURE, INC.

ARTICLE II

The duration of its existence shall be perpetual.

ARTICLE III

The Corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the Code). The purpose of the Corporation shall be to raise, receive, use, and distribute funds and to assist and provide information and programs for educational development of students with particular emphasis on assisting students with career and financial planning. public service web site to assist students, families, and others involved in education to enable them to find and use information and resources regarding higher education and careers arising out of such education, and other programs intended to promote such purposes. In addition to the foregoing purposes, the Corporation shall provide necessary facilities, offices, and activities incidental to the general purposes.

The Corporation, for the purpose of accomplishing the above, shall have any and all powers for every kind and nature whatsoever as are conferred by law and by the South Dakota Non-Profit Corporation Act and acts amendatory thereto and supplementary thereof.

ARTICLE IV

Upon the dissolution of the Corporation, the Directors shall, after paying or making provision for the payment of all liabilities and obligations of the Corporation, dispose of all the assets of the Corporation pro rata to the Partners of the Corporation provided they are either a state guarantee agency, or a guarantee agency which is an exempt organization under Section 501(c)(3), or to such organization or organizations organized and operated exclusively for the same purpose or purposes as this Corporation provided that such organization or organizors is/are described in Section 501(c)(3). However, any assets held by the Corporation, upon a condition requiring their return, transfer, or conveyance, which condition occurs by reason of dissolution shall be returned, transferred, or conveyed in accordance with such requirements.

ARTICLE V

The Corporation shall have one (1) class of membership, which members shall be called Partners. Partners shall be state guarantee agencies or tax exempt guarantee agencies under 501(c)(3) and who pay annual dues of membership.

ARTICLE VI

The Board of Directors is to have overall operational authority as described by the By-Laws of Mapping Your Future, Inc. in accordance with the South Dakota Non-Profit Corporation Act.

The Board of Directors shall consist of a group of not less than five (5) persons and the exact number shall be prescribed by the By-Laws of the Corporation.







The Corporation shall have one (1) class of membership, which members shall be called Sponsors. Sponsors shall be state guarantee agencies or tax exempt guaranteed agencies under 501(c)(3) and who pay annual dues of membership.




